**Course Description:** 3 credit hours.

Lecture/Lab/Clinical: Three hours of class each week.

Survey of all phases of theater including its history, dramatic works, stage techniques, production procedures, and relation to the fine arts. Participation in major productions may be required.

**Class Description:** Welcome to Introduction to Theatre! This course is designed to provide an introduction to theatre as an art form for both the major and non-major. The course will explore a wide-range of aspects of theatre as an art form and as a career. Emphasis will be placed on the collaborative role of theatre artists and the active role of audience; understanding of and access to live theatrical events and enhanced appreciation of value of theatre to society; development of critical thinking skills through consideration of representative examples of production. The course is open to all interested students and it fulfills the Visual and Performing Arts requirement at Northeast Texas Community College. Upon successful completion of this class, you should be able to identify basic theatre terminology; be knowledgeable of the major representational playwrights and their works; have a greater appreciation of all art forms and manners of artistic expression. I intend for this class to be fun! I will make every effort to create a positive, lively and friendly classroom environment. It is my hope that you will enjoy coming to class each day with the anticipation of learning about the varied and wonderful world of theatre. It is important that you understand that I want you to succeed. At the end of this class, it is my hope that you will have gained a significant respect and knowledge of theatre. In that vein, I promise to give my respect to you and to the course material.

## **Student Learning Outcomes**

**Upon successful completion of this course, students will:**

1. Analyze theater through written responses to play texts and/or live performance.
2. Demonstrate a basic knowledge of theater history and dramatic works.
3. Describe the collaborative nature of theater arts.
4. Demonstrate the relationship of the arts to everyday life as well as broader historical and social contexts.

## **Course Objectives:**

Students will comprehend and evaluate theatre production elements and values.

Students will understand the vast variety of careers in theatre.

Students will become familiar with the historical and cultural dimensions of theatre.

It is expected that through your active participation in this class that you will:

1. Become more proficient in the assessment, development, and application of your creative abilities.
2. Be able to identify basic theatre terminology.
3. Have a basic knowledge of a variety of acting techniques.
4. Have a good foundation of knowledge regarding the lives and creative works of representative playwrights, directors, designers and theatre luminaries.
5. Have a greater appreciation for the varied and significant artistic contributions from cultures different than your experience.
6. Have a greater understanding of the vast variety of careers in theatre.
7. Be able to articulate an informed personal reaction to works in the arts.

## Assignments:

The assignments include the following:

1. Taking exams (3) covering theatre terminology, the elements of a play, production staff positions and duties, genres of theatre, representative playwrights and plays.
2. Oral presentation in class discussing research into a selected element in theatre (artist, play/musical, historical period). The presentation will be 7 to 10 minutes and will be augmented with power point. A written summary and work cited notation will be submitted.
3. Viewing all Theatre Northeast productions and writing 4 to 6 page reaction papers.
4. The final assignment for the class will be a “creative presentation” demonstrating some facet of theatre; for instance: acting a monologue, writing a poem or a monologue, playing a musical instrument, performing expressive dancing, photography, designing scenery, costumes, lighting, make up or props, etc.

## Student Responsibilities/Expectations:

### Class Attendance:

It is expected that you will attend this class on a regular basis. Because the majority of the lecture information in this class is derived from a variety of sources it is very important that you attend class in order to get notes. I realize that emergencies may arise, or you may have conflicts for some of the scheduled classes. In those cases, it is strongly suggested that you contact me as soon as possible in order to “catch up” on your class work. Under normal circumstances, the formal attendance policy for this class is as follows: **You are allowed THREE emergency absences during the semester without overall grading penalty. Upon the FOURTH absence, the student’s final grade will be reduced by a Letter Grade in the course. Due to the daily interactive nature of the course, upon the SIXTH absence the student may be automatically: 1) dropped from the course or 2) fail the course (depending on the point of the semester). Please keep up with your absences in this course. This is your responsibility. Anyone who wishes to withdraw from the class must take the responsibility to formally drop by the designated date with the Office of Admissions.**

**Late Arrivals/Early Departures:**

Students must be one time for every class. Entering a class late or leaving early is disruptive to the flow of the class. Please be on time out of consideration to your learning process and the processes of others. If you are late for class, your participation grade will reflect this. This class will begin promptly at 1:30 pm! If you arrive after 1:40 pm you will be marked absent. Two documented "tardies" will result in one absence.

**Late Work:**

Late written work/projects will be deducted a full letter grade for each class period after the assignment is due. All written assignments are posted on the class calendar and in Blackboard.

**Extra Credit:**

There are opportunities for "extra" credit during the semester. During the final review for an exam, we will have a "Review Game" which will allow you to garner extra credit. All extra credit will be initiated by me. Please do not ask. In the circumstance that an opportunity for extra credit arises, this will be announced to the entire class.

Adaption of Assignments: Due to the fluid nature of this class, some assignments/scheduling may need to be adapted. All changes will be announced prior to implementation.

**Contacting the Instructor:**

Please feel free to visit me during my office hours at any time during the semester. I am here to help! If you can't make my office hours due to scheduling conflict, please set up an appointment with me. It is not an imposition. If something is occurring that is presenting you with difficulties with this class, let me know. Please don't be intimidated. Let's communicate with each other. The easiest and most reliable way to communicate with me is via email. I check it each morning when I arrive, during office hours and each end of the day.

**Other Important Information:**

1. When you are in the theatre, you must follow all safety precautions. The safety of our students in a learning environment such as our theatre are of the greatest Importance.
2. The Whatley Theatre is our home. I encourage you to feel at home and think of Theatre Northeast as a safe harbor--or perhaps an oasis in the desert. However, in our home, it is expected that you clean up after yourselves. Anything that you bring into the theatre must be disposed of properly after class or rehearsal. I might add that if you take pride in our home, it might even be a good thing to pick up after others who do not share the respect that you have for our home.
3. Theatre, by its' nature, is a very diverse and eclectic merging of personalities, cultures and life styles. I encourage you to embrace the wonderful diversity that is inherent

within the study and stagecraft of theatre. I have the expectation that you will treat each individual with respect and professionalism. Strive to "honor the art within yourselves." Although the class is about "drama," I strongly suggest that you leave your personal "drama" outside of the classroom. You may have the expectation that I will always treat you with respect and professionalism.

4. If you miss an examination, you must make arrangements to take the make-up exam before you attend the next scheduled class time. All missed exams will be administered in the College Testing Center located in B.T. 101.
