**Catalog Course Description (include prerequisites):** Four hours of class each week. Calculus II is a standard second course in the calculus. Topics include differentiation and integration of exponential, logarithmic and inverse trigonometric functions, integration of the trigonometric functions, various techniques of integration including u-substitution, parts, partial fractions, trigonometric substitution, rationalizing substitutions, approximate integration, applications of the integral for areas and volumes, surface area, arc length, infinite limits, indeterminate forms, L'Hopital's rule, improper integrals, sequences, series, convergence and divergence tests. Prerequisite: MATH 2413 with a grade of "C" or better.

### Evaluation – Honors Credit

- II. Author Maple Project with approved topic
- III. Brief research paper 2 3 pages Topic must be approved by instructor: Mathematician with significant contribution to the Calculus
- IV. Essay with Maple software Topic TBA

Each assignment is worth 25 points. The student's grade for honors credit will be based on 550 points which is 110% of the requirement for the regular credit. Grade Distribution: A - 495 points, B - 440 points
