Tests/Exams:

There will be two major proctored exams for the course in addition to online chapter quizzes. You must take the proctored midterm and final exams at an approved testing facility. For NTCC students, the best location is the college testing center located in the Business Technology building. For students at other colleges an approved testing location must be discussed with the course instructor. The online chapter quizzes can be taken at home. Quizzes will consist of mostly multiple choice questions with possibly a few short answer questions as well. The Midterm and Final Exams will consist of a multiple choice concepts section and a hands-on coding section. Students will be expected to do their own work on all quizzes and exams. Makeup tests will not be given unless arrangements have been made prior to the test time.

Assignments:

There may be some homework assignments such as textbook exercises. There will also be 4 - 6 programs assigned throughout the semester.

Other Course Requirements:

You will need a Java Compiler software tool in order to complete programming assignments for this course. I will give you more information on this later.

Each person, however, must develop his or her own solutions to the assigned projects, assignments, and tasks. In other words, students may not "work together" on graded assignments. Such collaboration constitutes cheating. A student may not use or copy (by any means) another's work (or portions of it) and represent it as his/her own.

If the instructor receives two or more assignments which appear to be identical and the result of dishonesty, all parties involved will receive a zero on that assignment. Keep track of your work and do not share with others. If multiple events like this occur, the instructor reserves the right to award a failing grade for the course.
