**Catalog Course Description:** Introduction to the history, principles, and practices of sustainable agriculture as applied to local and global agriculture. An evaluation of sustainability of conventional agricultural practices will also be made from the environmental, economic, and social perspectives ("planet, profit, and people"). Tools and assignments will be used to relate principles of sustainable agriculture to basic farming practices.

# **Student Learning Outcomes:**
