Evaluation and Grading Policy:

A. Major Exams, Final Exam, Davis Advantage Homework, Case Studies

4 major examinations = 60% of the course grade
 Comprehensive FINAL EXAM = 25% of the course grade
 Case Studies = 15 % of the course grade

a. Scantrons will be needed for exams.

Online "Davis Advantage" assignments are encouraged but not required.

- b. Davis Advantage Homework will NOT count as a grade. It is simply a learning assignment. Therefore, if you don't do it on time or don't do it, there are no point penalties. However, it is meant to further explain the chapters, so I **strongly encourage** you to do it.
- c. Case Studies will count as 15% of the grade.

- 3. You will need scantrons for exams, although there will also be case studies, problems, and short answer/essay questions on some of the exams. So, come prepared for anything.

D. CASE STUDIES

- 1. I will post these each Wednesday and we will meet and discuss them during lunch the following Monday. They are due at the beginning of class time the following Monday.
- 2. If lunch doesn't work, we will meet each Monday at either 7:00am or at 5:00pm for an hour to discuss them. These are CRITICAL to your understanding of the core concepts and they are excellent at teaching you how to think. I don't care if you can memorize and regurgitate; if you cannot do that you should not be in medicine. However, there is a tremendous difference in memorization of facts and the ability to apply them to a sick person. These cases will take you through the thinking process necessary to transition you from a regurgitator to a true diagnostician. They are what will make you a terrific medical professional.

Lecture-Associated Make-up Work:

- Make-up Exams: It is the student's responsibility to get in touch with the instructor immediately if an
