## **Evaluation and Grading Policy:**

- **A.** Lecture: 75% of the final course grade.
  - 4 major examinations will count as **40**% of the final course grade.
  - A comprehensive final exam (5th) will constitute **20** % of the final course grade.
    - See schedule for final exam date
    - Scantrons and a "Bluebook" will be needed for exams.
  - Online "Connect" assignments are required. Connect homework counts 15% of the course grade.
    - **LearnSmart** assignments are highly recommended. These guided readings help identify areas that you are having trouble understanding. These scores are NOT figured into the 15%; however, you may be given extra credit for doing them.
    - **Homework** is required and graded. These can be done 2 times before the due date with the highest grade counted. There is a 5% deduction taken for second try. Access to eBook and hints are available each time. After the first attempt the questions are displayed as correct or

- incorrect. Subsequent tries have more detailed feedback. There is no time limit. The homework will automatically be submitted on the due date whether completed or not. Study attempts are available on homework assignments after the due date without affecting the student's grade. No extensions can be made since study attempts are allowed.
- Quizzes will be available. These are used to test your knowledge of the material and helpful for exam preparation. Think of them as a pre-test. Usually 20 25 questions are pulled from a larger pool of questions. You may see new questions each time. You have unlimited attempts to complete the quiz. There is a 30 minute time limit. These scores will NOT count toward your course grade.
- What are Study Attempts? Study attempts allow students to retake and review the material,
  as well as get feedback, as many times as desired without the attempt affecting the grade. This
  option prevents the ability to give an extension if the due date is missed. If the due date is
  missed for any reason, a zero will be given.
- For Connect Homework, don't wait until the last day or two to complete the assignment. If you have Connect problems, that will NOT be a reason to be late. It is your responsibility to contact Connect and get any problems resolved. However, before you get in touch with Connect, contact me about your problem. This way I can check to make sure that everything is set correctly on my end. Since it may take me 24 hours to get back with you, this is even more reason not to wait until the last minute. #### **Lecture-associated Make-up Work:**

- Make-up Exams: It is the student's responsibility to get in touch with the instructor immediately upon his/her return if an exam is missed. If a makeup exam can be given, there will be no bonus points added. A failing course grade will result if the comprehensive final exam (#5) is missed or if two or more exams are missed. Changes to this policy are solely up to the discretion of the instructor.
- On occasion assignments may be given in class. There is no makeup for daily work. All assignments are due at the **beginning** of the period, and must be turned in **in person**. Lecture assignments will be **accepted only** on the due date.
- B. Laboratory: 25 % of the final course grade
  - 20% 4 lab practicals (5% each)
  - 5% Lab exercises/quizzes
    - The two lowest grades will be dropped

#### Lab-associated Make-up Work:

- Any lab practical missed will result in a grade of "0". If you know ahead of time about a conflict, it may be possible to schedule it with another section.
- Late lab reports or missed quizzes will not be accepted regardless of reason.
- Lab quizzes over the previous lab will be given at the beginning of the next lab.
  - Lab quizzes cannot be made up.
  - The student will not be able to begin the quiz if tardy.
  - Scantron(s) and a Blue Book (separate from those in lecture) will be needed for quizzes.

## Reminder to all Students Concerning the Laboratory Portion of the Course

- Absolutely no food or drink can be brought into the lab. Please consume all food and drink before you enter the lab.
- Lab books cannot be copied or copyright laws will be violated. Rental lab books or copies of lab books will not be accepted.
- To make the most of your laboratory experience, you will need to read each laboratory exercise **PRIOR** to attending lab each day. Familiarize yourself with all relevant terms and be sure that you have a general understanding of the objectives of each exercise.
- Portions of the Lab Assessment may be assigned to be completed before lab and will be checked for
  completion at the beginning of the lab period. The remaining laboratory exercise will be completed
  during the lab period. Turn in or have the entire lab assessment checked at the end of lab unless
  otherwise instructed. Keep up with all returned lab reports. Place them in a folder so you can use
  them to study from for the lab practicals.
- Dissections will be performed during the semester. Dissecting materials will be supplied. Gloves are recommended and are the student's responsibility. Gloves are not provided by the biology department.
- Each student will be required to bring a roll of paper towels for lab.
