General progress from week to week is expected. Daily practice is the only way to improve. In addition the student will play a final exam for the instructor at the end of the semester. The exam will consist of several prepared pieces and/or technical studies which will be assigned by the instructor.

The combined grades will count 75% of the student's total grade. The final exam will be worth 25%.
