Students will be required to visit TWO (2) court hearings throughout the semester. A written response to each visit will be required for this assignment. Responses should be type-written, #12

Times New Roman font and must be 1 - 2 pages in length. Instructor will provide specific prompts for each assignment in class.

# **BLACKBOARD ASSIGNMENTS:**

There will be thirteen (13) weekly Blackboard assignments to be completed by Sunday night, at 11:59 PM, of each week. Each assignment will be submitted through the Blackboard learning environment. Failure to complete the Blackboard Assignments will result in a grade no higher than a B in the course.

The instructor reserves the right to modify the topics to be covered in order to best prepare the student with the above stated learning outcomes.
