Catalog Course Description:

A general introduction to the visual arts designed to create an appreciation of the vocabulary, media, techniques, and purposes of the creative process. Students will critically interpret and evaluate works of art within formal, cultural, and historical contexts.

- 2. You must be punctual and attend class regularly. You must complete online assignments promptly. Late work is not accepted.
- 3. Wear comfortable clothing and shoes that are appropriate to working with equipment and supplies in the art and ceramic labs. NO OPEN TOES SHOES; NO SANDALS on the days we go into the ceramic lab. Floors may be wet and slippery.
- 4. Use class time wisely to complete your assigned projects.
- 5. Come to class with plenty of enthusiasm and energy.
- 6. Effort, progress, and improvement during the semester will be noted.
- 7. If you use a tool, clean it, and return it to the correct storage area. If you make a mess, clean it up. Wipe down your work area before leaving class. Push chairs under the desks/tables when leaving class. *Keep it CLEAN!* Studio maintenance and classroom cleanliness is your responsibility.
- 8. Students must respect other student's work as if it were their own and not touch any work except their own without permission.

- 9. In the ceramic lab, unfired clay is to be recycled, not thrown away.
- 10. You must check NTCC email and Blackboard daily. You must monitor YOUR GRADES in Blackboard and contact me if you have ANY questions.
