Course Description: A study of vehicle trim and glass service

End-of-Course Outcomes: Utilize tools and procedures for servicing interior and exterior trim including

glass, with emphasis on shop safety practice

Course Credit Hours: 3 Lecture Hours 2 Lab Hours 3

Textbook: Collision Repair and Refinishing Second Edition (Thomas/Jund)

Supplies: Spiral notebook and pen.

Course Description: Three hours credit. An in depth study of vehicle trim and glass service.

Course Learning Objectives: Upon successful completion of this course, the student will be able to:

Identify, remove and install all parts of an automobile's body and trim.

**Course Requirements:** Students must do the following:

- **1.** Attend class regularly and on time.
- **2.** Demonstrate knowledge of all learning objectives and competencies.

Course Format: The course will be presented with lectures including text and technique. A majority of the instruction will be in the lab with hands on experience.
