Please remember that this course is considered dual-credit, meaning that academic credit will be given for both Mount Pleasant High School and Northeast Texas Community College. It is your responsibility to learn the material, but please contact the instructor on any topics that need clarification or further assistance.

The most effective way to communicate with the instructor will be to come to class. The instructor will be in office during the provided class times and by appointment. The best way to make an appointment with the instructor is to communicate directly with the professor and immediate prior to or after class. Appointments can also be made by email.

Electronics: The use of electronics for any reason is strictly prohibited by both Mount Pleasant ISD and the instructor. There should be no use of headphones, cell phones, smart phones, or tablets of any kind. If research needs to be conducted, it should be done on your own time or with the permission of the instructor. There will be scheduled times available for the class to utilize the library. Upon entering the classroom, students are to place their electronics in the designated space provided.

- 5. Describe the structure of contemporary federal, state, and local justice agencies

Course Requirements

Pre-Requisite: Successful completion of Law Enforcement I. If you have not completed this course you need to speak with the instructor.

Class Format: Every effort will be made to provide the best possible learning experience for students by blending lectures, discussions, and appropriate reading assignments. We will be discussing many current, interesting, and often controversial subjects. This, a mature attitude is assumed of all students. Do nothing that will interfere with anyone else's opportunity to learn in this class. Disruptive behavior of any kind will not be tolerated.

Expectations: As a dual-credit course, the instructor expects the work completed during this course to reflect a higher level of education and effort. The instructor expects clear writing with adequate style, correct grammar, and proper use of scholarly references. All submitted written assignment must be typed in 12 point, Times New Roman font, double spaced, on standard paper with one inch margins. Additionally, this course will utilize **APA citation formation.** All research will be gathered from scholarly articles by utilizing informational databases. **WIKIPEDIA IS NOT A VALID SOURCE.** The instructor reserves the right to utilize plagiarism detection software and any paper found to have a significant amount of plagiarism (i.e., applying zero citations for borrowed work) will result in a grade of 0.

Exams: There will be two major exams during the semester: the mid-term (mid-semester) and the final exam (end-of-semester). Both exams will count as a test grade and utilize up to 100 true/false questions, multiple choice questions, and open ended questions. <u>All exams will be closed book</u> and closed note.

Quizzes: There will be weekly quizzes during the semester consisting of 10 true/false questions, multiple choice questions, and open ended questions. These quizzes will consist of material covered during that specific week. All quizzes completed during the course of the 6 week term will be averaged as a test grade for that specific 6 week term. All quizzes are open book and open note.

Written Assignments: There will be three written assignments over the course of the semester counting as test grades. Each written assignment will be focused on each of the core concepts of criminal justice: policing, courts, and corrections. Each paper will be a minimum of two pages, double spaced, size 12 point font, Times New Roman font, with 1 inch margins. Research for all written assignments should come from a scholarly database. So that I am aware progress is being made, rough drafts of all assignments will be due on a scheduled date and count as a daily grade. At the beginning of each 6 weeks, a handout will be provided with full detail regarding the written assignment. There will be scheduled computer lab time when available, but every effort to work on these assignments should be made by the student outside of class.

Bell Ringers: There will be daily bell ringers correlating to the topic of the day. These bell ringers are expected to be completed in the student's folder with 2-3 complete sentences.

Late Work: <u>I do not accept it.</u> You are aware of due dates for assignments, quizzes, and tests upon the acceptance of this syllabus. If for some reason you are unable to make a scheduled due date, the assignment should be submitted prior to the event (i.e. athletic events, fine arts events) or completed during the following school day. Additionally, the student may take the quiz during a scheduled time (i.e. tutorial period, lunch).
