Catalog Course Description (include prerequisites):

4 credit hours

Lecture/Lab/Clinical: Three hours of lecture and three hours of lab each week.

Prerequisite: MATH 2413 (completed or concurrent)

This is a calculus based course intended for students majoring in computer science, engineering, mathematics, physics, or related fields of study. Topics include 1-D motion, 2-D motion, rotational motion, Newton's laws, energy, momentum, equilibrium, gravity, oscillatory motion, waves, and heat.

Student Learning Outcomes: Upon successful completion of this course, students should (1) *understand advanced qualitative concepts*, and (2) *solve calculus problems of physics relating to* (1-7 below):

- 2425.1) Determine the components of linear motion (displacement, velocity, and acceleration), and especially motion under conditions of constant acceleration.
- 2425.2) Apply Newton's Laws to physical problems and solve problems involving forces and work.
- 2425.3) Identify the different types of energy and solve problems using principles of conservation of energy.
- 2425.4) Define the principles of impulse, momentum, and collisions and use the principles to solve problems involving momentum.
- 2425.5) Discuss rotational kinematics and dynamics and the relationship between linear and rotational motion, including center of mass and center of rotation, and use these concepts to solve problems involving rotational and linear motion.
- 2425.6) Define equilibrium, including the different types of equilibrium.
- 2425.7) Discuss simple harmonic motion and its application to real-world problems.

- 2425L.1) Prepare laboratory reports that clearly communicate experimental information in a logical and scientific manner and evaluate the accuracy of physical measurements and potential sources of error in measurements.
- 2425L.2) Relate physical observations and measurements involving classical mechanics to theoretical principles.
- 2425L.3) Design fundamental experiments involving principles of classical mechanics.

Through the core curriculum, students will gain a foundation of knowledge of human cultures and the physical and natural world; develop principles of personal and social responsibility for living in a diverse world; and advance intellectual and practical skills that are essential for all learning.
