# **Catalog Course Description (include prerequisites):**

Lecture/Lab/Clinical: Five hours of class each week (this includes homework).

A foundation studio course exploring drawing with emphasis on descriptive, expressive and conceptual approaches. Students will learn to see and interpret a variety of subjects while using diverse materials and techniques. Course work will facilitate a dialogue in which students will engage in critical analysis and begin to develop their understanding of drawing as a discipline.

## **Evaluation/Grading Policy:**

Grading – All assignments must be turned in by due dates announced in class. Assignments are graded by a rubric to be discussed in class.

40% - Drawing assignments 40% - sketchbook 10% - quizzes 10% - oral & written drawing critiques. If you miss class, you are responsible to get with a classmate for topics covered in the missed class. Coordinate with a classmate ahead of time. You must complete all assigned projects. *Work turned in late will receive one letter grade reduction*. Absenteeism and arriving late, or leaving early, result in loss of points to your overall grade. *More than two absences are detrimental to your final grade, and more than four absences will result in a drop from the course or a failing grade. Last day to withdraw with a "W" is November 15, 2016.* 

**Tests/Exams:** A total of seven quizzes, consisting of short answer, true and false, and fill in the blank type questions, on Blackboard, which will be available on Blackboard from Monday to Sunday the week that the quiz is due. Quizzes must be completed by midnight of the Sunday due date.

#### Assignments by Student Learning Outcomes (SLO's): SLO #1 – still life with emphasis on negative shape (descriptive)

SLO #2 – <u>2 different drawings</u>: one focusing on biomorphic form (conceptual) and one focusing on gesture (expressive).

SLO #3 – sketchbook, exploring a variety of materials (dry and wet, papers, etc.) and techniques. Sketchbook assignments are MOSTLY from the textbook and will be discussed in class and are in the calendar.

SLO #4 – displays in classroom and hallways – team work – collaboration and presentation. Collaboration with journalism class. Quizzes.

SLO #5 – 2 written (handwritten in sketchbook) and 2 oral critiques of a variety of drawings – yours, classmates, historical and/or contemporary artists. You must participate in all class critiques/reviews of drawings. See textbook for practicing directed looking and specialized vocabulary, pages 8-12.

SLO #6 – 3 reflections handwritten in sketchbook. 3 topics are: relating drawing to design, relating drawing to art history, and relating drawing to contemporary artist production. Think ART JOURNALING. You will reflect in your own handwriting (200 word minimum) on one page, and draw a corresponding composition on the opposing page.

### **CALENDAR OF CLASSES**

<u>Aug 22</u> - IN CLASS - Introductions; discuss syllabus, rubric, student art exhibit in spring semester, how to critique and analyze drawings, your sketchbook, and supply list.

**READ AND TAKE NOTES FOR QUIZ#1** - Contents, Preface, Part One Orientation and Introduction, Class & Critique (through page 19) in textbook.

**HOMEWORK** - read through page 19 and study for quiz #1, purchase supplies.

Aug 29 - IN CLASS - you must have all class supplies. Write your name on your supplies.

**SKETC**HBOOK ASSIGNMENT #1- page 18 in textbook, *Exercise 1.3: A Visual Chronicle of One Interior Space.* You will draw <u>in the classroom</u> for this exercise. You will draw three large areas in the room AND three details of objects in the room, for a total of six compositional study drawings in your sketchbook for this assignment. You will change medium and experiment with graphite pencil, charcoal, and black marker (NO COLOR). For example, each of the large area room drawings will be in a different medium: one in graphite pencil, one in charcoal, and one in marker. Repeat the different mediums for the details of objects drawings.

# HOMEWORK - Think about how drawing relates to ART HISTORY, so you can write and draw in your sketchbook. READ AND TAKE NOTES FOR QUIZ on Contents, Preface, Part One Orientation and Introduction, Class & Critique (through page 19) in textbook.

<u>Sept 5</u> –no class (Labor Day). College closed. Develop ideas about how drawing relates to art history. What will you write about, and what will you draw on the opposing page to illustrate your reflection?

**Sept 12** – **IN CLASS** - Review pages 14 and 15 in textbook about self-critique. Oral critique#1 of one of your large area sketchbook exercises. **DUE TODAY -** Reflection #1 – write on one page and draw on opposing page in sketchbook– topic is *HOW DOES DRAWING RELATE TO ART HISTORY?* HOMEWORKThink about some ideas for presentation of student art in the classroom and hallways. Jot down some at least five ideas in sketchbook to share for next class. Quiz #1 is open Sep 12-18 in Blackboard; complete quiz NLT midnight, Sep 18. Bring five still lifeitems for next week's assignment. READ AND TAKE NOTES FOR QUIZ on Chapter 2, Materials, Procedures, and Concepts, pages 20-46.

**Sep 19** – IN CLASS - Classroom display and hallway boards (teamwork). Discuss Appendix A Materials and Processes, pages 383-397. Use easel,drawingboards, and dry mediums for Ex.2.1, Scribbled Armature(pg 26) and Exercise, Mass Gesture (pg 27), and Ex.2.4 Blind Contour(p.28) on provided paper. HOMEWORK- Quiz #2 is open Sep 19-25 in Blackboard; complete quiz NLT midnight, Sep 25. Make sure you have five still life objects for next week's assignment. READ & TAKE NOTES FOR QUIZ #3 on Chapter 3, Organic Mark & Form pages 48-77. On Blackboard, find design handout; print and bring to class next week.

**Sept 26-** IN CLASS- Discuss design elements and principles. Complete Ex. 2.12, Analyzing Negative Shape, Part II (pg 40) - set up still life, draw three quick compositional studies in your sketchbook with dry media and a final accurate and sensitive drawing on provided paper. HOMEWORK- Develop ideas about how drawing relates to design elements and principles. What will you write about? What will you draw on the opposing page that goes along with the reflection? Refer to handout on Blackboard and textbook for design. Quiz #3 is open Sep 26-Oct 2 in Blackboard; complete quiz NLT midnight, Oct 2. READ & TAKE NOTES FOR QUIZ #4 on Chapter 4, Geometric Mark & Form pages 78-107. Oct 3- IN CLASS - Sketchbook Link: Texture Marking, p.57. Vary your marks of an irregular subject. One full page in sketchbook. HOMEWORK - Quiz #4 is open Oct 3-9 in Blackboard; complete quiz NLT midnight, Oct 9. READ & TAKE NOTES FOR QUIZ #5 on Chapter 5, The Experience of Space, pages 108-136 and Appendix B, pages 398-411.

<u>Oct 10</u>- IN CLASS - Sketchbook Link: Cross-Contour Hands, p. 68. Two pages in your sketchbook - one loose and one tightly connected cross contour. DUE TODAY - Reflection due in sketchbook – write one page and draw on opposing page – topic is HOW DOES DRAWING RELATE TO DESIGN ELEMENTS AND PRINCIPLES. Homework - Quiz #5 is open Oct 10-16 in Blackboard; complete quiz NLT midnight, Oct 16. READ & TAKE NOTES FOR QUIZ #6 on Chapter 6, Value: Light and Form, pages 137-166.

Oct 17 – IN CLASS - Two pages in sketchbook and a variety of mediums, draw expressive lines. See Ex. 3.1 Expressive Line, p.69. <u>Mid term - all previously assigned work is due.</u> Homework – Quiz #6 is open Oct 17-23 in Blackboard; complete quiz NLT midnight, Oct 23. READ & TAKE NOTES FOR QUIZ #7 on Chapter 7, Value: Idea and Response, pages 167-191.

<u>Oct 24</u> – IN CLASS - oral critique #2 of your descriptive drawing. Quiz #7 is open Oct 24-30 in Blackboard; complete quiz NLT midnight, Oct 30. HOMEWORK -research Surrealist artists: Jan Miro, Yves Tanguy, and Salvador Dali for ideas for your conceptual drawing. See page 67 in textbook for example of biomorphic drawing.

<u>Oct 31</u> - IN CLASS - In sketchbook, brainstorm three full page ideas for biomorphic. Conceptual drawing approach on sheet paper provided in class with focus on biomorphic form. Conceptual drawings are a concept, or idea, which take precedence over tradition. Think UNREAL blobs with volume.

<u>Nov 7</u> –IN CLASS - continue work on conceptual drawing. DUE TODAY - Written critique in sketchbook of a classmate's conceptual drawing. Homework – Research artists – Cezanne, Picasso, Kandinsky, Robert Motherwell, and Willem de Kooning.

<u>Nov 14</u> – IN CLASS - Expressive drawing approach on provided paper with focus on gesture. Think of more intimate and freer forms, like Cezanne, Picasso, Kandinsky (Modernist) and the Abstract Expressionists Robert Motherwell and Willem de Kooning's drawings; drawings about feelings, fantasy, or dreams. Homework-Develop ideas about how drawing relates to contemporary artist production. What will you write about?What will you draw on the opposing page that goes along with the reflection?

<u>Nov 21</u>- IN CLASS - Finalize your drawings. DUE TODAY - Written critique in sketchbook of a classmate's expressive drawing. Reflection due in sketchbook – write one page and draw on opposing page –topic is RELATING DRAWING TO CONTEMPORARY ARTIST PRODUCTION.

**Nov 28-** last class day. All assignments and sketchbook must be completed and turned in for grading by end of class.

Dec 5- no class, but you can pick up your sketchbook and drawings between 0900 and 1000.

Please note: The calendar is a guide, and the instructor my change dates and/or assignments as necessary.

# **Other Course Requirements:**

Some basic papers and supplies are furnished, but students will be required to purchase their own drawing materials.

Supplies: You can find these items in the college bookstore, Hobby Lobby, Michaels, and Walmart.

Sketchbook (drawing journal) 9x12. Must be spiral bound and good for graphite and charcoal drawings. Graphite pencils – 2B, 4B, 6B and ebony – Derwent and Staedler are good brands.

Conte crayons -2 white, 2 black. You can get red-brown ones to experiment with, but they are not required.

Pencil sharpener

Charcoal - a variety of vine, compressed, and pencil

3-4 paper stumps (also called a tortillion)

Chamois piece for blending. You can get a large car chamois (not the synthetic kind) and cut it up. Kneaded eraser

Magic Rub eraser by Stanford (white eraser)

Jumbo binder clips – 2 each

A container for your supplies and a portfolio for your drawings are optional.

Still life objects that are personal to you, at least five objects - some tall, some short.

Your OWN photographs – no magazine images, no celebrities (unless you took the images yourself), no anime, no formal studio poses

Textbook - available at the bookstore or order online
