# Homework Assignments:

There will be two (2) independent homework assignments throughout the course. Each assignment will be worth 100 points of the student's total grade. Students are expected to work independently on homework assignments and to not share their work with classmates. Prompts for each assignment will be handed out in class. Students are to respond to the prompt with a 3-5 page written paper. All homework assignments will be type-written, double spaced, #12 font, and formatted in APA Citations. All reference material must be cited.

The instructor reserves the right to modify the topics to be covered in order to best prepare the student with the above stated learning outcomes.
