### **Catalog Course Description (include prerequisites):**

Through a series of lectures, class discussions, and in-class listening the student will become acquainted with the main currents of Western musical tradition from the Middle Ages to the present. Emphasis will be placed on enhancing appreciation for music in all its forms.

### **Course Objectives:**

Underlying the course content is the notion that an intelligent appreciation of music is dependent on two important factors.

- A basic understanding of musical terms and compositional means, i.e., understanding how composers write their music
- A general understanding of the important influences on a composer's life and work that affect their musical style

As understanding on both levels grows, the ability to critically understand and appreciate music grows. Upon successful completion of this course, the student will have:

- Gained basic skill in the above-mentioned areas
- A basic vocabulary with which to discuss music
- Become acquainted with the six major historical periods and a number of representative composers and works from each period
- Be able to identify and discuss important style characteristics from each period.

Having acquired these basic skills, students will be encouraged to continue to broaden their music appreciation on their own for their future enjoyment.

### **Student Learning Outcomes:**

By the end of the course the student will be able to:

1. identify major historical periods
2. describe the salient features of musical composition from each historical period
3. analyze music and ascertain the utility of the work

**Lectures & Discussions:**

There are ten chapters in the textbook. Class presentations will include a lecture accompanied by a PowerPoint presentation, appropriate musical examples and class discussion. Chapter PowerPoints can be downloaded from the Blackboard course website.

Additional resources for this course can be found on the textbook website, <http://webcom2.grtxle.com/musicexperience>. Instructions for registration and access to this website will be provided on the first day of class.

**Exams:**

There will be 5 exams covering two chapters each. Each exam is worth a possible 150 points each. Each exam will have 5 music matching questions worth 10 points each and 50 multiple-choice questions worth 2 points each, 25 from each chapter covered. The exams are timed, and you will have 90 minutes in which to complete the exam. Exams will be taken in the course site on Blackboard.

**Assignments:**

You will attend two live musical events and prepare a written reaction paper for each event. Approved events are listed below. If you desire to attend an event other than those on the approved list, you must receive prior approval by the instructor. The reaction papers are worth 125 possible points each. Papers will be submitted through Blackboard. Guidelines for writing the reaction paper are posted on the course Blackboard site.
