Course Objectives:

1. Provide basic patient care including bathing, feeding, toileting and ambulating patients as well as obtaining vital signs and reporting any abnormal values to the licensed nurse
2. Acquire and distribute patient care supplies
3. Change bed linens and process dirty linens properly
4. Perform safety checks to keep patient rooms clean and clutter - free

5. Obtain EKG readings
6. Perform phlebotomy procedures
7. Discontinue IV and Foley catheters using standard precautions and per physician order

Additional Program-specific Eligibility Requirements

- Phlebotomy Technician Certification (CPT): Each candidate for the CPT certification must be able to provide evidence that he/she has performed a minimum of thirty (30) venipunctures and ten (10) capillary sticks on live individuals.

- EKG Technician Certification (CET): Each candidate for the CET certification must be able to provide evidence that he/she has performed a minimum of ten (10) EKGs on live individuals.

Administered medication prior to passing math exam
Unprofessional communication with client staff, peers, others

10-15 points

Absence without notification
